Applications are invited for the following contractual positions at 06 (Six) De-addiction cum Rehabilitation Centres being set up in the districts of Tinsukia, Dibrugarh, Golaghat, Sonitpur, Kamrup and Barpeta under the State Anti-drug and prohibition Council, Assam for an initial period of 12 (Twelve) months which may be extended based on performance.

1. Name of the position: Project Co-ordinator cum Vocational Counsellor

Number of vacancy position: 06 (Six) one each for the newly set up centre.

Educational Qualification: Graduate in any discipline from a recognised University.

Experience: Minimum 03 (Three) years of experience of managing such centres or demonstrable capabilities for running such centres. Candidates must have working knowledge of computer.

Age: Maximum age should not be more than 45 years as on 01.01.2021.

Remuneration: The remuneration would be INR 1.80 lakh per annum i.e. 15000.00 per month.

2. Doctor (Part time)

Number of vacancy position: 06 (Six) one each for the newly set up centre.

Educational Qualification: MBBS

Experience: Should hold a training certificate in Addiction medicine from a recognized institute.

Age: Maximum age should not be more than 45 years as on 01.01.2021.

Remuneration: The remuneration would be INR 1.98 lakh per annum i.e. 16500.00 per month.

3. Counsellor/Social Worker/Psychologist

Number of vacancy position: 18 (Eighteen) one each for the newly set up centre.

Educational Qualification: Graduate in any discipline from a recognized university

Experience: Three years experience in the field of de-addiction counselling and should have a certificate by NISD (National Institute of Social Defence), also should have knowledge of English and regional language.

Age: Maximum age should not be more than 45 years as on 01.01.2021.

Remuneration: The remuneration would be INR 1.50 lakh per annum i.e. 12500.00 per month.

Educational Qualification: Diploma in Nursing from recognized institute.

Experience: Should be trained by a recognized Government Medical Institution.

Educational Qualification: Class X passed.

Experience: Preferably experienced in such centres and must be trained in NISD.

Age: Maximum age should not be more than 45 years as on 01.01.2021.

Remuneration: The remuneration would be INR 1.32 lakh per annum i.e. 11000.00 per month.

The service may be renewed solely based on performance, output and desired conduct. The Council will have the right to end the contract at any point of time with a prior notice of one month.
2. The successful candidates will have to sign a contractual agreement in the prescribed format.
3. The contract shall not confer any right or claim of extension/absorption in the Council at any point of time whatsoever.
4. The Selection Committee will prepare a short list of candidates on the basis of their past experience of handling similar types of assignments, educational background and domain knowledge. Date of interview will be intimated to the shortlisted candidates. The Council reserves the right to cancel/postpone the appointment, if so required.
